THE NRA BANNED GUNS GIVEAWAY (“GIVEAWAY”) BEGINS AT 12:01 AM EASTERN DAYLIGHT TIME (“EDT”) ON 5/13/19 AND ENDS AT 11:59 PM EDT ON 10/11/19 (“GIVEAWAY ENTRY PERIOD”).
